2024 CEHA Dues **Information**

Dues invoices were mailed to be received in early January for CEHA. The 2024 dues amount is \$340.00; however, a \$10.00 discount is available to you, and you can pay \$330.00 if your payment is received on or before January 31, 2024 and all outstanding dues are paid in full.

If you pay in February, you will owe \$340.00 plus a \$3.40 late fee. You can pay online through PayPal, but a PayPal fee will be included in your payment amount. JANUARY 2024 — CHURCHILL ESTATES





As the winter season is here and many more of us are out enjoying the Churchill Estates community, we receive a number of calls expressing concerns from residents about certain issues. Here are the Top 7 to be aware of this winter:

1. Trailers, RVs and Boats – If you own a trailer, RV or boat, remember that they are not to be parked in the driveway, street or yard.



2. Pets – Enjoy walking the neighborhood with your pet, but be sure to clean up after them. *Please keep pets inside during freezing weather or someplace warm.*



3. Yard trimmings – Be sure to dispose of clippings properly. Clippings are not to be blown into the street or into neighbor's yards.



4. Trash Receptacles – Trash cans should be stored out of sight after their designated pick up day. You can place inside your garage or behind a fence. Your neighbors will appreciate it!



5. Driver Safety – Be sure to watch your speed in the neighborhood, and be sure to not exceed 30 miles per hour. Come to complete stops at stop signs and save texting for when you are home safely



6. Airplane Noise Bothering

You? – Call the San Antonio Airport Noise Mitigation Office at 210/207-3471 to report low or loud



aircraft flying over your Churchill Estates residence. Thank you for being a good neighbor in Churchill Estates! The smallest gestures can make the biggest difference.

7. Parked Car Reminders

The State law requires any vehicle stopped or parked on any public street to be facing the flow of traffic. This violation occurs more often while parked in front of your residence.

For all our residents who love to play tennis and pickleball, be sure to reserve days and times online. Please visit: https://churchillestateshoa.skedda.com/booking to select a time that works best for you.

We encourage residents to be mindful of the number of reservations made. Here are few rules and reminders as you book time on the courts:

- Court use is limited to CE residents and their guests. A resident must accompany guests at all times.
- Courts must be yielded to those having advance reservations.
- Proper tennis attire and etiquette is requested. Good judgment, sportsmanship and courtesy shall be applied at all times.
- Courts are for tennis and pickleball only. Toys, skates, bikes and other activities are prohibited.

BRUSH COLLECTION DAY SET FOR WEEK OF 01/22/2024

The City of San Antonio twice-annual brush collection day for the Gates at Churchill Estates is scheduled for the week of January 22, 2024. The city usually circulates a flyer confirming the brush pick-up date. Brush should be placed within 8-feet from the curb and ready for pickup no later than 7:00 AM, Monday, January 22. Brush piles should not exceed 8-cubic yards. This month is the perfect time for trimming tress and bushes on your property, especially any limbs or branches that extend over streets or sidewalks. Also be sure to cut back any trees or branches that block street signage and impede traffic.

PARKING AND TOWING POLICY **VIOLATION STICKERS**

Last February, the Board of Directors implemented a Parking and Towing Policy for the Gates at Churchill. Vehicles that are in violation of the parking policy may receive a "parking violation sticker". The sticker will provide details on the violation. Vehicles that fail to comply with the parking violation notice may be towed at the owner's expense.

The Parking and Towing Policy is posted on the community https://www.ciaservices.com/docs/CHHOA/ Notice of Dedicatory Instruments.pdf. Homeowners who rent their properties are advised to notify their tenants about the Parking and Towing Policy.

TRIPLE CROWN GATE MANAGEMENT

Maintenance and repair are essential for the operation of the entry/exit gates in our community. Last November and December, some drivers experienced problems entering and exiting the gates at Triple Crown. The Board is aware of the issues and will continue to work with experienced gate contractors to ensure the gates function properly. Homeowners who have problems with the gates should submit a notice to the CIA Services customer service center from the community website.

Drivers are also encouraged to drive carefully when entering and exiting the gates, and avoid using the entry gate to exit.
